The Bitter Experiences of a Falun Dafa Practitioner Police Officer

(Clearwisdom.net) Falun Dafa practitioner Sun Jihong, age 40, was the former police station chief for the Forestry Bureau in Huanan County, Heilongjiang Province. Before he began practicing Falun Gong, Mr. Sun had a problematic personality. After he started practicing, he changed himself and got rid of many bad habits. Because he was persistent in his belief in "Truthfulness-Compassion-Tolerance," the authorities illegally arrested and detained Mr. Sun numerous times. He was tortured to death in 2002 during an interrogation.

Sun Jihong appealed many times for justice for Falun Gong ever since the persecution began in 1999 and was arrested many times. On February 4, 2002 (Beijing Falun Dafa Day), Mr. Sun went to Tiananmen Square and unfurled a banner with the words, "Falun Dafa is Good." The Tiananmen Square police took him away and detained him at the Tiananmen Square Police Station. He told the arresting police that the "self-immolation incident" was a plot directed by the authorities. Mr. Sun miraculously walked out of detention later on.

Someone betrayed Mr. Sun, leading to his arrest on the night of May 10, 2002. While in detention, he undertook a hunger strike to protest the persecution. When the local police were taking him back from Beijing to his hometown, Mr. Sun jumped off the train and safely escaped. On September 25, 2002, around 6:00 p.m., Sun Jihong was arrested by the Fengtai police when he was changing his ride on the Yuquanying Highway, Fengtai District, Beijing. They conducted a torture-style investigation, and on the fourth day after his arrest, September 29, 2002, Sun Jihong was tortured to death.

When his family came to see the body, they couldn't even identify him. The police had to clean the bloodstains off his face, so the family was able to identify Mr. Sun. The family found him almost too horrible to lay eyes on. His head was swollen and misshapen. There was a hole between his eyebrows. There were six round holes on his face; two of them near one of his cheeks. Some holes looked like cigarette burns. There was a mass of lacerations and bruises all over his body from severe beating. The police were afraid of being sued by the family and had to compensate the family over 10,000 yuan (approximately 1,265 USD). They forbade photographing the remains, and cremated the body quickly. The authorities strictly blocked the information regarding Mr. Sun's death. His body was cremated against the family's wishes on October 2, 2002.

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. Introduced by Mr. Li Hongzhi in China, the practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-Forbearance in daily life. Sanshui Labor Camp Refuses Relatives' Request for the Release of Practitioners

(Clearwisdom.net) Ms. Jiang Jiayin and Ms. Jiang Lanlan (sisters), and Mr. Wu Xiyuan are practitioners in their fifties. On June 8, 2006, they were arrested and detained for four months in a brainwashing session held in Sanshui Labor Camp. The sisters' grandmother, who is 85 years old and paralyzed, cries every day because her family members were forced to leave home to avoid being arrested or detained.

On the morning of September 22, 2006, Jiang Jiayin's and Jiang Lanlan's mother, and a member of Mr. Wu Xiyuan's family went to Sanshui Labor Camp to request the release of their relatives. The Jiang sisters' mother wore a T-shirt to the labor camp with the following words written in large letters: "**Wronged**" and, "**Give me back my daughters Jiang Jiayin and Jiang Lanlan.**" On the back it said: "**There is no crime in having a faith, stop the persecution.**"

When the authorities saw that Mses. Jiang's mother was wearing a truth-clarifying T-shirt and carrying a poster board, more than twenty guards were sent out to seize the board. The T-shirt was violently stripped off their mother by the guards. The guards then threatened her, "If you do this anywhere else, you will be sentenced to several years in prison."
